5.6. Interactive Map Editing Session

During this agenda item, the Commission will engage in an interactive and live map editing session with its demographer, FLO Analytics. This interactive and live map editing session would only include the maps selected by the Commission for further consideration pursuant to agenda item #5.5. The intent of this item is for the Commission to discuss and analyze any proposed comments, edits or changes to the remaining maps. The City's demographer will be making Commission-requested edits in real time and displaying those changes on screen to provide visual feedback, as well as ensuring that the proposed edits to the draft maps comply with the law and render a map feasible.

RECOMMENDATION

Commission to hold a discussion on procedure for final map adoption.

BACKGROUND

Article XI, Section 11.10 of the Roseville City Charter states the following about the procedure for adoption of a final map:

Sec. 11.10. Adoption of redistricting report and map.

A. The commission shall file a preliminary redistricting plan and draft map with the City clerk, along with a written statement of findings and reasons for adoption, which shall include the criteria employed in the process and a full analysis and explanation of decisions made by the commission. The City clerk shall publish the preliminary redistricting plan and draft map at least thirty (30) calendar days prior to the adoption of a final redistricting report and final map.

B. During the thirty (30) calendar day period after publication, the commission shall hold at least five (5) public hearings, including one (1) public hearing in each existing council district.

C. After having heard comments from the public on the preliminary redistricting plan and draft map, the commission shall adopt a final redistricting report and final map. A commission-adopted final redistricting report and final map has the force and effect of law and is effective thirty (30) calendar days after it is filed with the City clerk and shall remain effective until the adoption of new district boundaries following the next federal decennial census. The council may not rescind, supersede, or revise the district boundaries adopted by the commission.

In order to determine the process of how the Commission would like to adopt a final map, staff recommends that the Commission consider the following procedural items and make decisions on how it would like to handle the following:

- How to interpret the language in Article XI, Section 11.09.B.1. regarding "areas that are

separated by a railyard or a highway are not contiguous.”

- Whether any of the maps are complete and can adopted “as is” tonight.
 - o If so, how will they be narrowed down or selected?
 - Ballot?
 - Motion?
 - Ranking?
 - Point value?
 - Other?

- If no map can be adopted “as is” without further line editing, how does the Commission want to handle the interactive line drawing session in agenda item #5.6 in an open and transparent manner? Some of the preliminary items that should be considered are:
 - o If the Commission narrows down to less than six (6) maps for further discussion in agenda item #5.5, how would they like to handle that?
 - Ballot?
 - Motion?
 - Ranking?
 - Point value?
 - Other?

 - o If the maps are narrowed down and edits are made to draft maps during the interactive line drawing session during agenda item #5.6, are there any limitations on the type or number of edits that may be made to a map?
 - Any discussion regarding minor or substantive edits?
 - Can any Commissioner suggest map edits or is majority approval of the Commission needed for any edits?
 - Any other concerns to discuss regarding potential map edits?

 - o If maps are edited, how will we identify those edited maps?
 - A1, B1, etc?
 - Any other suggestions or concerns?

 - o If maps are edited during agenda item #5.6, how would the Commission like to handle the selection of a proposed final map?
 - Ballot?
 - Motion?
 - Ranking?
 - Point value?
 - Other?

 - o Any other procedural items that the Commission would like to discuss prior to having a substantive discussion about the map boundaries?

BACKGROUND

Following the selection of a proposed final map, the Commission will have an open discussion regarding the proposed final map and how much it differs, if at all, from one of the six (6) draft maps selected by the Commission for further consideration at its December 20, 2021 meeting. A commission-adopted final redistricting report and final map has the force and effect of law and is effective thirty (30) calendar days after it is filed with the City clerk and shall remain effective until the adoption of new district boundaries following the next federal decennial census. The council may not rescind, supersede, or revise the district boundaries adopted by the commission.

If the Commission takes the position that the proposed final map selected during item #5.7 differs in such a manner that the Commission determines that the proposed final map should be considered a new “draft” map pursuant to subsection A of section 11.09 of Article XI of the City Charter, then the Commission may direct staff to follow the procedures noted above for an additional thirty (30) day publication period of the proposed draft map selected during agenda item #5.7. The Commission should also consider whether additional public hearings would be required to discuss the proposed draft map selected during item #5.7.

If the Commission takes the position that the proposed final map selected during item #11 may be moved forward for final adoption without an additional 30 day publication period, the City Attorney’s Office recommends that the proposed final map be published on the City’s website for at least seven (7) days prior to final map adoption, pursuant to California Elections Code section 21628(d) (1).

Any and all Independent Redistricting Commission meetings associated with final map adoption will be properly noticed pursuant to the Brown Act and will be open and available to the public.
