Dear Mr. Frank and Commissioners,

Thank you for carrying forward at your December 20, 2021 meeting, Map 6 - that is now retitled Map B - as one of the six maps under final consideration to define Roseville City Council Districts for the next ten years as set forth in your "Preliminary Redistricting Plan and Draft Map Analysis - December 22, 2021".

The Sun City Roseville Community Association (the Association) has reviewed your Analysis and recommends that you adopt Map B (formerly Map 6). The configuration of Map B best represents and retains the continuity and "community of interest" of the Sun City Roseville community in Council District 4. The Association's previous letter (of December 20, 2021 - as attached) to you sets forth the basis and is again the recommendation of the Association for the Commission to adopt Map B.

Additionally, the Association recommends that the Commission delete Maps D, E and F from any further consideration. This is because each of these three maps remove Sun City Roseville from Council District 4 and places the community in Council District 5. Sun City Roseville's "community of interests" are closely associated with development within Council District 4 and not Council District 5. When the areas now within existing Council District 5 were planned, it was done under different land use development intentions and financing decisions. As such, homeowners in Council District 5 pay higher fees and taxes as best illustrated by the mandated and very costly additional monthly Mello-Roos assessment placed on each homeowner. This is not the case at all in Sun City Roseville. Thus, the Association recommends that Maps D, E and F be removed from any consideration by the Commission.

In the Independent Redistricting Commission's consideration to narrow to three (3) to five (5) maps - of the twenty-three (23) proposed redistricting maps under consideration for possible new boundaries for the five (5) single-member City Council Districts - at your December 20, 2021 meeting followed by decision of one final map at your January, 2022 meeting, the Sun City Roseville Community Association (the Association) submits the following comments and recommendation to you.

The various documents and twenty-three (23) Public Maps available at the Commission's website have been reviewed. Likewise, the understanding that the purpose of the Commission is to assure that council districts are geographically contiguous and substantially equitable in population has been taken into account in preparation and submission of the Association's letter and recommendation to you.

Background:

The Association in 2019 supported the City Council's decision to transition from at-large to district-based single-member districts and elections as embodied in the City Council's Ordinance No. 6161 as adopted on December 4, 2019. The Association supported both the City Council's action to form five (5) separate single-Districts and more specifically the creation of the boundaries of current Council District 4.

Recommendation:

As the boundaries of Council District 4 are being considered now by the Commission among the nearly two dozen proposed maps, the Association recommends that the redistricting boundary for Council District 4 as identified on Public Map 6 (dated November 8, 2021) be adopted.

Public Map 6 assures Council District 4's continuance of a compact community of interest both across and within an easily identifiable geographic area. Public Map 6 for Council District 4 is bounded by easily identifiable major street boundaries on its west, south and east and the City of Roseville boundary-line (with the County of Placer) on the north.

Further, the single-family residential and supporting commercial development of the area identified in Public Map 6 for Council District 4 was generally planned over the same time-line by the City. Likewise, the subsequent growth of single-family residential homes/units occurred over the same general span of time thus giving it a strong commonality of similar community interests.

Additionally, our Sun City Roseville community in 2019 and in 2021 remains the most significant in size as well as to population of single family residential adult living communities within the City of Roseville, within Council District 4 as depicted in Public Map 6.

The Association's recommendation as depicted in Public Map 6 for Council District 4 underscores the continuance of the Association's previous recommendation in 2019. Now, as the Commission performs its primary duty to assure that council

districts be geographically contiguous and substantially equitable in population - as based upon federal decennial population data for Roseville as taken in the year 2020 - Public Map 6 for Council District 4 is the map recommended to the Commission by the Association.

Conclusion:

The retention of a tightly drawn and geographically cohesive Council District 4 as set forth on Public Map 6 is recommended by the Association to the Commission for your action at your December 20, 2021 meeting as well as Public Map 6 is recommended to the Commission for your final action to be taken at your January, 2022 Commission meeting.

Thank you for volunteering your time and services on the Commission for the City of Roseville and, on behalf of your fellow citizens.

1. What are the common interests in your community? Describe how they are important:

My community (Vineyard) has a lot of younger children and youth. We go to Heritage Oaks Elementary, and know/bond with so many of the nearby families. I also notice a lot of us share similar hobbies, professions and the priorities for the services and the programs Roseville offers.

2. Explain the geographical location of your community of interest. What are the physical boundaries?

The general geographic boundaries of my community tends to start at Vineyard, and go as far North as Pleasant Grove; it goes as far West as Junction (St. Clare); there is not as much connection with my side of Foothills Blvd (West) and that of the East side (nearer to Denio's and the train station). The economic / income difference seems to separate the two sides of Foothills.

3. What is the rationale for your community of interest to be used in the City Council redistricting process?
Please describe how the issues before the City Council have an impact on your community.

There is a very tight connection with the Vineyard community (the circles off of Riesling Drive) and those around the Heritage Oak Elementary school. So many of the parents and kids are close and play sports and other recreational activities together. The economic and professional connection among parents is also very similar compared to other adjacent communities (South and East, such as Roseville Heights and Theiles Manor).

4. What else would you like to tell us about your community?

I think Map E (as of 1/4/22) is the most ideal for my community, while Map C is the next closest. 95% of the other families in Roseville that me and my family (and other friends in this area) connect with (personally and professionally) are within the proposed boundaries. Whereas there would be a bigger disparity keeping Vineyard with any of the other areas and not including the Kaseberg/Kingswood, Foothills Junction and Woodcreek Oaks communities.

To: Roseville Independent Redistricting Commission

I have watched with interest as the commission has done its work. At this point I feel compelled to speak up in the process.

I grew up in Roseville. Having lived here almost all my life, (my father was Chamber President in the early 1960's) I understand our history and culture. I understand how hard many have worked to protect it – and we are at a moment where it is at risk.

I spent 10 years serving the residents of the city and the City Council on the planning commission. We worked hard to create neighborhoods and ensure that we did not become just another bedroom community of the bay area – and as a matter of fact, folks moved here to get away from there in many cases, and those of us that grew up here don't want that to be our future for our children.

I failed to speak up during the county process and must say I regret it. It is clear to me and many others (which may be a result of my family's lifelong engagement in our community here) that the ultimate plan adopted for redistricting was clearly designed to punish some, while protecting a couple of supervisors, with little to no recognition of the realities, history, and identity of Placer County, thanks in large part to a vocal and manipulative minority. I would have never guessed that outcome.

I hope I am wrong, but those same forces appear as clear as daylight in some of these maps (which may be a result of my family's lifelong engagement in our community here). Particularly maps A, D, E, and F. To punish, and gerrymander, for political gain, while disenfranchising a significant number of citizens for the benefit of a few special interests. That is not our history, not our tradition. We honor our community, we honor our citizens, and when we stop doing that, well, we are just another urban town with no identity left.

A couple key points, likely in the category of calling out the elephant in the room and pointing out that the emperor has no clothes:

1. Districted elections, by their nature, pit citizens and parts of cities against each other, just look at Sacramento's history. But we don't get to do anything about that. We just have to make the best of it.
2. Solid Council districts are based on planning corridors, the primary foundational element of every city government, not neighborhoods that either choose to self-identify with each other or not based on who shows up.
3. RCONA's, and I was around when they were first formed, are not planning agencies, they are neighborhood associations that were intended to strengthen neighborhood watch and bring neighbors together. They are not a political subdivision of planning or elected district boundaries. In my 10 years on the planning commission, I saw the challenges RCONAs have faced being productive in planning decisions firsthand.
4. To adopt any map that prevents a significant number of City citizens from voting for 6 years is unconscionable.

I encourage you to do the right thing:

- Adopt maps that are a logical progression from the last maps adopted, while fixing the mistakes of the past.
- Adopt maps that follow logical planning corridors, processes, and history.

You have a Couple maps here that are worthy of consideration, specifically maps B and C, and clearly a few maps, like A, D, E, and F, that pander to non-elected political operatives and special interests while disenfranchising large numbers of voters in the city.

Make a choice to rise above the parochial special interests and do the right thing.

Good evening, City of Roseville Independent Redistricting Commissioners,

My name is Kayla Scott, a fourth-generation Roseville native, born and proudly raised in our expanding city limits. I grew up in and attended Roseville City schools and graduated from Oakmont High School alongside my husband. My husband and I have deepened our generational roots in Roseville by raising our three-year-old daughter, a fifth-generation Roseville resident, at 303 Rich Bar Court near Heritage Oak Elementary. As I work for a small business based in Roseville and proudly serve on the City's Library Board, I am emotionally and civically invested in the success and equity of how our city operates. Thank you for the opportunity to be heard tonight.

Upon careful consideration of the six proposed redistricting maps, I urge the Commission to remove Maps A, D, E and F from final consideration. While Maps B and C offer the lowest percentage of total population deviation, my request is that you push Map B into final consideration and official adoption.

Map B offers up to 3% less total population deviation, allowing for a more equitable distribution throughout the city. Map B also places my neighborhood in District 2 as opposed to my current District 5. We know that our current District 5 will need to retreat more West to consider the needs of that growing population. I find this to be a fair adjustment and allows Map B's newly proposed District 2 to include my daughter's school district, as well as neighbors most impacted by decisions in the Foothills/Junction neighborhoods.

Map B also offers the proposed new District 2 a "closer to ideal" deviation. In this map, District 2 will only deviate by over 158 compared to map A's deviation of under 199. Map B provides the strongest stability and as best possible follows our geographic boundaries of neighborhoods, specific plans and school districts. There are many reasons why Roseville is considered and voted one of the best cities to live, buy a home, raise a family and retire. In order for our city to remain one of the best places to live, work and play in California's Megaregion, we are required to maintain solid, community inspired leadership. I believe that small changes are good changes, incremental transitions that will allow continuity of leadership with experienced, caring Councilmembers.

Please consider my request to remove Maps A, D, E and F from consideration and select Map B as our final adoption of the redistricting process. Thank you for your service and attention to the equity of our beloved city.

"Please take into account that there are a lot more communities of interest that bind Roseville citizens together outside of neighborhood associations. A person might work in one portion of the city, live in a second, and socialize in one or more others.

Just because there are neighborhood associations lobbying to keep their areas together when the new map is drawn doesn't make a case for this being the prime driver of how maps should be drawn - there are many persons such as myself that live in areas with inactive neighborhood associations, and we wouldn't use it as a criteria for drawing maps. Thank you so much.

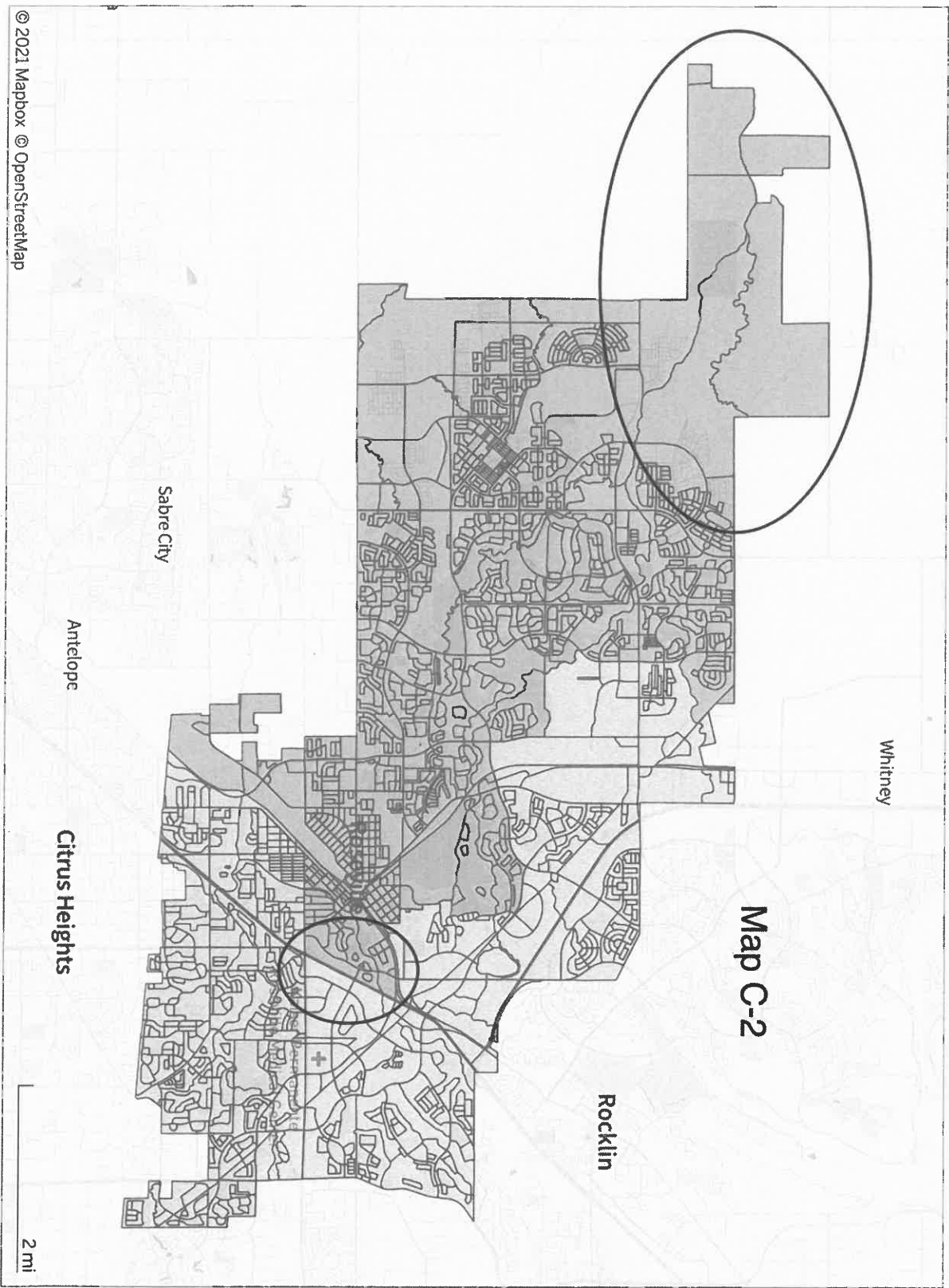

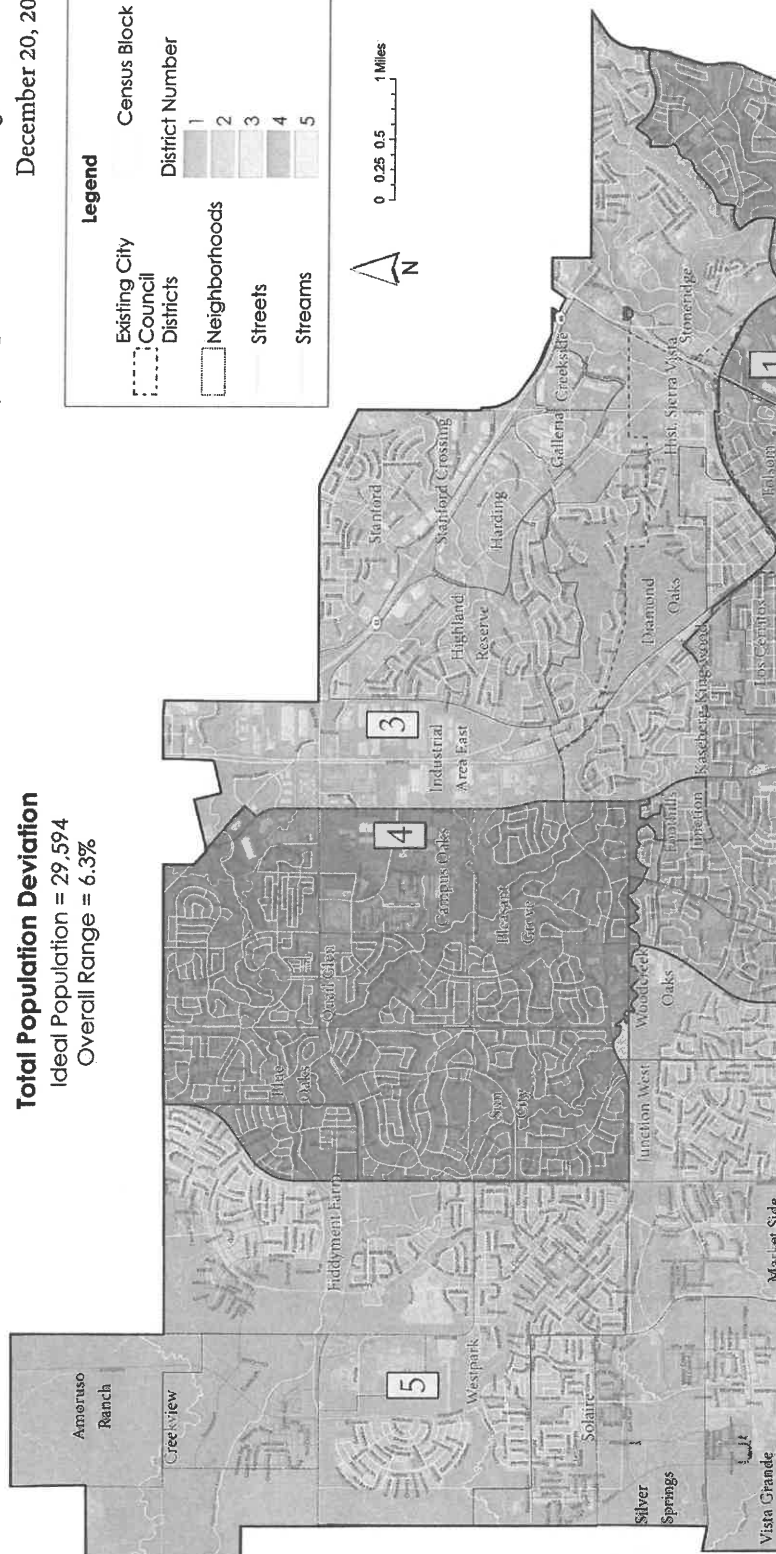
