The funding source is the Technology Replacement Fund, which is supported entirely by development through permit fees for development-driven technology improvements, resulting in no impact to the General Fund.

7.5. I-80 Auxiliary Lanes Project - Temporary Construction Easement Deed Amendment

Memo from Senior Engineer Mark Johnson and Development Services Director Mike Isom recommending the City Council adopt RESOLUTION NO. 24-057 APPROVING AN AMENDMENT TO TEMPORARY CONSTRUCTION EASEMENT DEED FOR THE INTERSTATE 80 AUXILIARY LANE PROJECT, AND AUTHORIZING THE CITY MANAGER TO EXECUTE IT AND ALL RELATED DOCUMENTS ON BEHALF OF THE CITY OF ROSEVILLE. On April 7, 2021, City Council approved authorization for the City Manager to execute a Temporary Construction Easement Deed associated with the Interstate 80 (I-80) Auxiliary Lanes Project, administered by the South Placer Regional Transportation Authority. Due to unforeseen circumstances, the Project was delayed, resulting in a change to the estimated completion date to the spring of 2026. The proposed amendment would extend the expiration date of the construction easement to May 1, 2026, consistent with the I-80 Auxiliary Lanes Project's expected completion date. The requested action has no fiscal impact to the City's General Fund.

The Housing Division has funding available in the Local Housing Trust Fund and will pair it with available resources in the Housing Successor Low and Moderate Income Housing Asset Fund. The recommended agreements will support the City's General Plan in meeting the affordable housing goals. No General Fund resources will be used in the development of this project.

8.2. Draft Transportation Sales Tax Expenditure Plan

Memo from Administrative Assistant Lainie Anderson and Public Works Director Jason Shykowski recommending City Council adopt RESOLUTION NO. 24-058 APPROVING A DRAFT TRANSPORTATION SALES TAX EXPENDITURE PLAN. Staff requests Council approve the Draft Transportation Sales Tax Expenditure Plan (DTSTEP) prepared by the Placer County Transportation Planning Agency. The DTSTEP contains a list of improvements that would be funded with potential future transportation sales tax revenues. The DTSTEP would only become effective in the event the transportation sales tax initiative is placed on the November 2024 General Election ballot and the voting public approves the initiative. Approximately \$1.2 billion in potential transportation revenue is projected for a proposed 30-year ½ cent sales tax district in the South County. Depending upon future populations changes in the region, Roseville could receive up to \$150 million of direct transportation related financial assistance over the next 30 years in addition to the benefits of the proposed regional roadway improvements.

9.1. Tax and Equity Fiscal Responsibility Act Hearing for Gibson Drive Apartments

Memo from Management Analyst Jeannine Thrash and Assistant City Manager/Chief Financial Officer Dennis Kauffman recommending the City Council conduct a public hearing and adopt RESOLUTION NO. 24-059 APPROVING THE ISSUANCE OF THE CALIFORNIA MUNICIPAL FINANCE AUTHORITY EXEMPT FACILITY BONDS FOR A QUALIFIED RESIDENTIAL RENTAL PROJECT IN AN AGGREGATE PRINCIPAL

AMOUNT NOT TO EXCEED \$95,000,000 FOR THE PURPOSE OF FINANCING OR REFINANCING THE ACQUISITION, CONSTRUCTION, IMPROVEMENT AND EQUIPPING OF GIBSON DRIVE PHASE I & PHASE II AND CERTAIN OTHER MATTERS RELATING THERETO. Staff requests Council approve the issuance of the Bonds by the California Municipal Finance Authority ("CMFA") for the benefit of the Borrower. Roseville Affordable LP (the "Borrower"), a partnership of which Shea Properties (the "Developer") or a related person to the Developer is the general partner, has requested that the CMFA adopt a plan of financing providing for the issuance of multifamily housing revenue notes or bonds (the "Bonds") in one or more series at no time to exceed \$95,000,000 in outstanding aggregate principal amount, to finance the acquisition, construction, improvement and equipping of a multifamily rental housing project located at 540, 556, 564, 572 and 580 Gibson Drive, Roseville. The Board of Directors of the California Foundation for Stronger Communities, a California non-profit public benefit corporation (the "Foundation"), acts as the Board of Directors for the CMFA. Through its conduit debt issuance activities, the CMFA shares a portion of the issuance fees it receives with its member communities and donates a portion of these issuance fees to the Foundation for the support of local charities. With respect to Roseville, it is expected that 25% of the issuance fee, or approximately \$25,000, will be granted by the CMFA to the General Fund of the City. Such grant may be used for any lawful purpose of the City.
