#### 6.2. Hall Park Play Structure Replacement - Contract Purchase Agreement

Memo from Park Planning & Development Superintendent Tara Gee and Parks, Recreation & Libraries Director Jill Geller recommending the City Council adopt RESOLUTION NO. 24-256 APPROVING A CONTRACT PURCHASE AGREEMENT, BY AND BETWEEN THE CITY OF ROSEVILLE AND PLAYPOWER LT FARMINGTON, INC. AND AUTHORIZING THE CITY MANAGER TO EXECUTE IT ON BEHALF OF THE CITY OF ROSEVILLE (3003671). Staff requests Council approve a contract purchase agreement with PlayPower LT Farmington, Inc, for a not-to-exceed amount of \$219,817.17, for the Hall Park play structure replacement. On March 14, 2024, staff sought public feedback for a new play structure at Hall Park. The outreach process included social media and onsite signage with a QR code inviting residents to review, comment and vote on the proposed play structure design. Through a two-week write-in period, feedback received was minimal. Nine comments were received and indicated general support with requests for shade and an Americans with Disabilities Act (ADA) swing. The play structure design includes shade and an ADA swing was added to the swing area. The funding for this play structure replacement was approved by Council in the FY2023-24 Capital Improvement Program using the Parks, Recreation and Library Capital Projects Fund. Delivery of this play structure is expected in fall/winter 2024. Maintenance is funded by the General Fund and will not increase.

The total Merakisis contract amount shall not exceed \$600,000, which is six percent (6%) of a potential \$10,000,000 grant award. Merakisis shall only be compensated upon successful award of a CFI grant to the City, upon which they will be compensated up to 6% of the awarded and completed grant project amount. Should no grant be awarded, Merakisis will not receive compensation. No City funds, beyond the 6% of an awarded CFI grant, are being requested for this agreement.

Memo from Community Service Officer Erika Broussard, Police Captain Josh Simon, and Deputy City Attorney Travis Cochran recommending the City Council introduce for first reading an ORDINANCE OF THE COUNCIL OF THE CITY OF ROSEVILLE AMENDING CHAPTER 9.10 OF TITLE 9 OF THE ROSEVILLE MUNICIPAL CODE REGARDING MASSAGE SERVICES; and adopt RESOLUTION NO. 24-271 ADOPTING MASSAGE EXEMPTION CERTIFICATE APPLICATION AND RENEWAL FEES AND INCORPORATING THE FEES INTO THE SCHEDULE OF USER AND REGULATORY FEES. Staff requests Council approve the establishment of a new permitting fee. The resolution and fee only become effective upon final adoption of the Ordinance. Chapter 9.10 of the Roseville Municipal Code regulates massage services within the City. Since adoption of the current ordinance regulating massage services, many other jurisdictions have changed the way they regulate massage businesses, including increased education and training standards for massage therapists. These changes, among other things, have led to increased issues with illicit massage business activities within the City. The primary purposes for updating this chapter of the municipal code are to address ongoing challenges with illicit massage business activity and to better align the City's regulations with state law and the City's neighboring jurisdictions. There is no fiscal impact associated with the proposed ordinance, as massage business enforcement is already budgeted. The recommended exemption certificate application fee and renewal fee were developed to recover the applicable processing costs.
